Central Government vide not dt 03-08-18, has deferred the requirement of achieving MPS of 25% by 2 years from the date of commencement of the Securities Contract (Regulation) (Second Amendment) Act, 2018 i.e. upto 02-08-20 and further central government notification dt 31.07.2020 it is deferred by 3 yrs,i.e,02-08-2021 We submit that Bank will adhere to all timelines in compliance with respect to MPS.
