

It is obligatory that the provisionally selected candidates should produce all original documents to prove their eligibility w.r.t experience certificate, qualification etc. as laid down in the notification for Lateral Recruitment of Specialist Officers in JMGS-I, MMGS II and MMGS III dated 27.06.2023.
